
WHEREAS, State Highway Route 275, lying within the City of West Sacramento, between State Route 50 and the Sacramento River, has been deleted by legislative enactment, namely Assembly Bill 3020, Chapter 1154 Statutes of 1996; and

WHEREAS, by cooperative agreement dated October 6, 1999, between the City of West Sacramento and the State of California, the City agreed to accept title to a said portion of State Highway Route 275, upon relinquishment thereof to said City by the State of California; and

WHEREAS, by said cooperative agreement the City of West Sacramento is willing to accept a lump sum payment as the State's total responsibility to place said portion of Route 275 in a state of good repair; and

WHEREAS, this Commission does hereby approve the terms and conditions of said cooperative agreement; and

WHEREAS, in accordance with said legislative enactment, this Commission has found and determined, and does hereby find and determine, that it is desirable and in the public interest that said highway be relinquished to the City of West Sacramento for use as a city street;

NOW, THEREFORE, IT IS VOTED by the California Transportation Commission that it relinquish and it does hereby relinquish, to the City of West Sacramento, effective upon the recordation of a certified copy hereof with the Recorder of Yolo County, all of the State of California's right, title and interest in and to said State highway, described as follows:

All that portion of deleted State Highway as indicated by outlining and designated as Segment to be Relinquished shown on those certain highway maps filed on December 16, 1999, in State Highway Map Book No. 3 at pages 25 through 28, inclusive, Records of Yolo County.

EXCEPTING AND RESERVING to the State of California any and all rights of ingress to and egress from the Highway hereby relinquished in and to the adjacent and adjoining freeway, except at such points as are now or may be established by resolution of this Commission.

ALSO RESERVING unto the State of California an AERIAL EASEMENT for freeway purposes, an easement and right of way to construct, replace, inspect, maintain, repair, operate or remove an overhead freeway bridge and highway, supporting columns and

footings, including any and all appurtenances thereto, over, under, upon and across the following described real property, together with all abutter's rights of access to and from the adjoining property to the freeway viaduct upon, over and across that portion of the Route 275/50 westbound ramp lying between the westerly limits of the Relinquishment and 50 feet easterly of said westerly limits and that portion of the Route 50/275 eastbound ramp lying between the westerly limits of the Relinquishment and 680 feet easterly of said westerly limits.
